The UnitedHealthcare Children's Foundation (UHCCF) is a 501(c)(3) charitable organization that provides medical grants to help children gain access to health-related services not covered, or not fully covered, by their families' commercial health insurance plan. Families can receive up to \$5,000 annually per child (\$10,000 lifetime maximum per child), and do not need to have insurance through UnitedHealthcare to be eligible.

Since 2005, UHCCF has awarded more than 34,000 grants valued at over \$70 million to children and their families across the United States. And we're just getting started. We're setting our sights on 2030, where we aim to award our 50,000th medical grant to families in need.

# Apply for a UHCCF grant online:



1. Family applies via **UHCCF.org**.



2. UHCCF will notify the family of approval within 30-60 days of receiving the application.



3. Once approved for a grant, the family will need to submit a request(s) for payment online for approved medical services/items.\*



4. Payments may be issued to a provider, vendor or guardian.

*\*Due to the confidential nature of the information being shared, we are only able to accept payment requests directly from the approved family.*

## UnitedHealthcare Children's Foundation medical grants help families focus on what really matters most – the child's wellbeing.

### Eligibility Criteria:

- ✓ Child must be 16 years of age or younger at the time of application, live in the United States, and facing a clinical condition.
- ✓ Child must be covered by a commercial health insurance plan.  
*Please note: The coverage does not have to be through UnitedHealthcare.*
- ✓ Family must not exceed maximum eligible adjusted gross income as documented on IRS Tax Form 1040.

Family Size	Adjusted Gross Income
2 people	\$65,000 or less
3 people	\$100,000 or less
4 people	\$135,000 or less
5+ people	\$170,000 or less

## What can the grant cover?

Approved items related to covered services for children's health care and well-being, such as therapies, durable medical equipment, hospital stays and more.

Most standard/FDA approved services are eligible. However exclusions do apply.\*\* To see a full list of exclusions, visit our website.



**Important reminder: Once you incur a medical expense, you have 60 days to apply for a UHCCF grant. Upon grant approval, you must use the funds to pay the expense within a year. Don't wait. Apply immediately.**
